SUGA'S CHAIRMAN DR. NG CHI HO IS CONFERRED THE TITLE OF UNIVERSITY FELLOWSHIP BY HONG KONG POLYU

Suga International Holdings Limited ("SUGA" or the "Group") (stock code: 912), a leading electronic total solutions provider with a pet food and accessories business, has announced that **Dr Ng Chi Ho, Chairman of the Group**, today was conferred the title of University Fellowship by The Hong Kong Polytechnic University ("PolyU") in recognition of his outstanding contribution to PolyU and community.

Dr Ng's relationship of long standing with PolyU started when he first joined the Hong Kong Polytechnic as a lecturer in the Department of Electronic Engineering. He has been dedicated to connecting industries and facilitating expansion into overseas markets, witnessing the rapid growth of Hong Kong's electronic industry. In 2017, electronic products accounted for two-thirds of Hong Kong's total export value, making it the biggest contributor to the Hong Kong economy in terms of exports.

Dr Ng said, "I am most delighted and deeply honoured to receive this prestigious title of University Fellow from PolyU. Running a business is similar to conducting research at university as one must keep up with changing times through lifelong learning. PolyU has long been an important partner of the industry and their research has always been in line with industry trends. We must strengthen our capabilities in this area to achieve sustainable growth and keep pace with the keen competition in the global market. In view of this, I have actively invested in start-ups, hoping to support new talent. A pipeline of quality talent is essential to this innovation and technology development. I am confident that PolyU will continue to empower aspiring professionals with the knowledge, insight and entrepreneurship to make great contributions to the technological innovations in Hong Kong."

Presided over by Mr Chan Tze-ching, Chairman of the University Council, the conferment ceremony was held at the Jockey Club Auditorium on the PolyU campus. The recipients were warmly greeted by PolyU President, Professor Timothy W. Tong and other senior staff members of PolyU.
